Proceedings of the 18th Annual General Meeting of SQS India BFSI Limited (Formerly Thinksoft Global Services Limited) held on Thursday, July 28, 2016

The Eighteenth Annual General Meeting of the Company was held on Thursday, July 28, 2016 at 3.30 p.m. at The Residency Towers, The Town Hall, 115, Sir Thyagaraya Road, T Nagar, Chennai 600 017.

Mr. David Bellin, Chairman of the Board of Directors, chaired the meeting. The Chairman called the meeting to order after confirming the requisite quorum for convening the valid Annual General Meeting under Section 103 of the Companies Act, 2013 was present.

Attendance:

Members present in person – 174 holding 2,99,548 shares Members present through proxies - Nil Corporate members - 2 represented by authorised representatives holding 57,53,901 shares

The Chairman then welcomed the Shareholders of the Company to the 18th Annual General Meeting and introduced the Board of Directors and the Company Secretary of the Company to the Shareholders. The Chairman informed the Shareholders that Mr. Ulrich Baümer, Independent Director, could not attend the meeting and explained the reasons for the same.

The Chairman acknowledged the attendance of the statutory auditors, M/s. PKF Sridhar & Santhanam LLP, Chartered Accountants and Secretarial Auditors, M/s. M Alagar & Associates, Company Secretaries in Practice.

The Chairman informed the members that necessary statutory registers as required under Companies Act, 2013 are kept open for inspection by the members.

The Chairman stated that the Notice of the 18th AGM was already circulated to all the Members along with the Annual Report of the Company for the financial year 2015-16. With the consent of the members present at the meeting, the notice of 18th AGM dated 28th April, 2016, was taken as read.



The Chairman further informed to the Members that the Auditors' Report and its Annexure for the year ended 31st March, 2016 does not contain any qualification, observation or comments on financial transaction or matters, which have any adverse effect on the functioning of the Company. Therefore, as per Section 145 of the Companies Act, 2013, the Auditors' Report and its Annexures need not be read at the meeting.

The Chairman also informed that the Secretarial Audit Report issued by the Company Secretary in Practice, does not contain any qualification, observation or comments and therefore need not be read at the meeting.

The members were informed that in compliance with Regulation 44 of Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, Section 108 of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014 and amendments thereto, the Company has provided opportunity for the members to do e-Voting. The Remote e-Voting portal was open from 9.00 a.m. IST, Monday, July 25, 2016 and ends to 5.00 p.m. IST Wednesday, July 27, 2016 (both days inclusive).

Also, the Company has provided the facility for voting at the venue of the Annual General Meeting through electronic voting system (i.e. Insta Poll) for Members who have not cast their vote through remote e-voting.

It was further informed that the Company engaged the services of M/s. Karvy Computershare Private Limited (Karvy Selenium Tower B, Plot No 31 & 32, Gachibowli, Financial District, Nanakramguda, Serilingampally, Hyderabad – 500 032) to provide E-Voting platform to the members and Mr. V. Suresh, a Company Secretary in Practice, (Membership No. 2969) (Address: No.28, 1st Floor, Ganapathy Colony, 3rd Street, Teynampet, Chennai – 600 018) was appointed as the Scrutinizer to scrutinize the Insta Poll and remote e-voting process in a fair and transparent manner.

The Chairman in his speech gave an overview on the performance of the Company for the financial year ended March 31, 2016.

The Chairman conducted the proceedings of the items set out in the Notice one after another along with the object and implication of each resolution except the 3rd item relating to his own reappointment and members were invited for discussion. Several members addressed the meeting, provided suggestions and sought clarifications. The Chairman and Directors addressed the same.

Since Mr. David Bellin is an interested party to the resolution pertaining to his re-appointment, with the consent of Members, Prof. K. Kumar chaired the proceeding of that particular item and explained the object and implication of the resolution. After completion of this item, Mr. David Bellin resumed the Chair.

Thereafter, the Chairman requested all the members and proxy holders present at the meeting and who did not cast their vote through re-mote e-voting system to participate in the Voting through Insta Poll.



The Chairman announced that the results of the e-voting, along with Consolidated Scrutinizer's Report would be placed on the Company's website, website of Karvy Computershare Private Limited by 30th July, 2016 and it shall also be submitted to the Stock Exchanges.

With that, the Chairman concluded the meeting with vote of thanks.
