Proceedings of the 22nd Annual General Meeting of Expleo Solutions Limited (Formerly known as SQS India BFSI Limited) held on Thursday, August 27, 2020 through Video Conference (VC) / Other Audio-Visual Means (OAVM)

The Twenty Second Annual General Meeting of the Company was held on Thursday, August 27, 2020 at 3.30 p.m. IST through Video Conference (VC) / Other Audio-Visual Means (OAVM).

As there is no full time Chairman on the Board, as per Article 77 of Articles of Association of the Company, the Directors present in the meeting elected Prof. K. Kumar, Deputy Chairman and Director to Chair the 22nd Annual General Meeting.

Prof. K. Kumar, Deputy Chairman and Director, accepted the invitation and chaired the meeting.

The Chairman called the meeting to order after confirming the requisite quorum for convening the valid Annual General Meeting under Section 103 of the Companies Act, 2013 was present.

Attendance:

Corporate members present : 2 Corporate represented by its authorised through VC

representative holding 57,72,791 shares

The Chairman then welcomed the Shareholders of the Company to the 22nd Annual General Meeting (22nd AGM) and informed that the meeting is being held through VC / OAVM as per the provisions of Companies Act, 2013 and circulars issued by Ministry of Corporate Affairs and Securities and Exchange Board of India.

The Chairman requested the Board of Directors, Chief Financial Officer and Company Secretary of the Company to introduce themselves to the Shareholders and they did the same.

The Chairman acknowledged the attendance of the statutory auditors, M/s. Kalyaniwalla & Mistry LLP, Chartered Accountants and Secretarial Auditors, M/s. M. Alagar & Associates, Company Secretaries in Practice.

The Chairman informed that the Company has taken all feasible efforts under the current circumstances to enable members to participate through video conference and cast their votes electronically. Members who have not cast their votes yet and who are participating in this meeting will have an opportunity to cast their votes during the meeting through the e-voting system. He thanked all the members, colleagues on the Board, auditors and the management team for joining this meeting over video conference.

The Chairman informed the members that necessary statutory registers as required under Companies Act, 2013 are kept open for inspection electronically by the members.

The Chairman stated that the Notice of the 22nd AGM was already circulated electronically to all the Members along with the Annual Report of the Company for the Financial Year 2019-20. With the consent of the members present at the meeting, the notice of 22nd AGM dated May 28, 2020, was taken as read.

The Chairman further informed to the Members that the Auditor's Report and its Annexure for the year ended March 31, 2020 does not contain any qualification, observation or comments on financial transaction or matters, which have any adverse effect on the functioning of the Company. Therefore, as per Section 145 of the Companies Act, 2013, the Auditor's Report and its Annexures need not be read at the meeting.

The Chairman also informed that the Secretarial Audit Report issued by the Company Secretary in Practice, does not contain any qualification, observation or comments and therefore need not be read at the meeting.

The members were informed that in compliance with Regulation 44 of Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, Section 108 of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules, 2014, and amendments thereto, the Company has provided opportunity for the members to do e-Voting. The Remote e-Voting portal was open from 9.00 a.m. IST, Monday, August 24, 2020 and ended on 5.00 p.m. IST, Wednesday, August 26, 2020 (both days inclusive).

Also, the Company has provided the facility for voting during the Annual General Meeting through electronic voting system for Members who have not cast their vote through remote e-voting.

It was further informed that the Company engaged the services of M/s. Central Depository Services (India) Limited (CDSL), to provide E-Voting platform to the members and Mr. V. Suresh, Company Secretary in Practice, (Membership No. FCS 2969, Certificate of Practice No.6032) (Address: No.28, 1st Floor, Ganapathy Colony, 3rd Street, Teynampet, Chennai – 600 018) was appointed as the Scrutinizer to scrutinize the voting during 22nd AGM and remote e-voting process in a fair and transparent manner.

The Chairman in his speech gave an overview on the performance of the Company for the financial year ended March 31, 2020.

The Chairman conducted the proceedings of the items set out in the Notice along with the object and implication of each resolution.

The Chairman invited the Members who registered themselves to speak at the AGM, as stated in the Notice of AGM, for discussion. Several members addressed the meeting, provided suggestions and sought clarifications. The Chairman, Managing Director & CEO, Chief Financial Officer and Company Secretary & Compliance Officer clarified the queries raised by the members.

Thereafter, the Chairman requested all the members present at the meeting and who did not cast their vote through remote e-voting system to participate in the electronic voting offered by CDSL.

The Chairman announced that the results of the e-voting, along with Consolidated Scrutinizer's Report would be placed on the Company's website, website of M/s. Central Depository Services (India) Limited by August 29, 2020 and it shall also be submitted to the Stock Exchanges.

With that, the Chairman concluded the meeting with vote of thanks.
